GLLC members who arrive early will have an opportunity to tour the revitalization efforts underway in the Buffalo River Area of Concern and the City of Buffalo's waterfront. Declared functionally dead in 1969, the Buffalo River is one of the many waterways that have benefited from the federal Great Lakes Restoration Initiative. The \$1.3 million invested by the U.S. Environmental Protection Agency in Remedial Action Plan coordination leveraged an additional \$75 million in public and private funds for the river cleanup. These activities have helped transform this once polluted river into a recreational and tourism destination that is a vital economic and environmental asset for the City of Buffalo and western New York.

#### 10:30 – 11:10 am Update on Asian Carp and Efforts to Control its Spread

States from across the region, in collaboration with the federal government, continue to monitor the movement of Asian carp and implement strategies to prevent this aquatic invader from reaching the Great Lakes. In this session, legislators will receive an update on the Asian Carp Control Strategy Framework as well as explore future monitoring and prevention plans.

# 11:10 am – 12 pm Binational Cooperation on Reducing Phosphorus Loadings and Harmful Algal Blooms

The Great Lakes Water Quality Agreement charges the U.S. and Canada with taking steps to "restore and maintain the chemical, physical, and biological integrity of the waters of the Great Lakes Basin Ecosystem." Managing nutrient loads is one of the activities intended to ensure that the water is "drinkable, fishable, and swimmable." This session will explore the problem of nutrient pollution that causes toxic algal blooms and low-oxygen areas in Lake Erie, both of which negatively impact water quality in the lake. Attendees will learn about the impact of phosphorus pollution on Lake Erie, the proposed targets for reducing phosphorus loadings recommended by the International Joint Commission, and the steps legislators can take to help address the problem.
